

## *Membership Program Terms & Conditions*

---

Set forth below are the terms and conditions of membership in the A.J. Rose Carpets & Flooring Interior Design Affiliate (IDA) Program. A.J. Rose Carpets and Flooring may change the Interior Design Affiliate Program or these Terms & Conditions from time to time, without notice. Changes to this program will be posted online at [www.ajrosecarpets.com/id](http://www.ajrosecarpets.com/id). A.J. Rose Carpets and Flooring reserves the right to terminate the Interior Design Affiliate Program or any membership at any time, without notice. Any changed Terms & Conditions become effective immediately upon being posted, and your continued use of your membership constitutes your agreement to the then-current Terms & Conditions.

**Eligibility** - This membership program is offered to eligible interior designers through authorized A.J. Rose Carpets and Flooring Retailers. Approved IDA members may use their membership at any participating A.J. Rose Carpets and Flooring Design Center.

**Rewards** - Qualified enrolled interior designers who present a membership card at the time of purchase will receive their discount by one of the following methods, depending on how the purchase is made:

If you purchase products for your clients:

Qualified enrolled interior designers who present a membership card at the time of purchase will receive a 15% discount on all qualified materials only. Exclusions apply. Orders must be paid in full to receive discount.

**OR**

If you select items for your clients to purchase on their own:

Qualified enrolled interior designers who refer clients to A.J. Rose Carpets and Flooring will receive a referral fee equivalent to a 15% discount on all qualified materials only. Exclusions apply. Referral fees will be paid in the form of a check within 60 days of purchase, upon payment in full and delivery of products. Referral fee is 15% of materials only. Does not apply to installation services and labor. Coupons, sale and promotional items are exempt from this program.

To ensure smooth cashiering of a referred purchase in the event of a designer's absence during a client sale, the designer must coordinate a buying appointment between the client and A.J. Rose Carpets and Flooring. To facilitate this process, A.J. Rose Carpets and Flooring will provide referral/appointment cards for designers to share with clients, conveniently entering the date and time of the appointment and membership information for recording and cashiering eligible purchases.

**Exclusions** - The 15% member fee discount or commission is on materials only and does not apply to labor, installation or services. The 15% discount can't be combined with any other sale offers, discounts, coupons, sale items, and promotional sales and events. A.J. Rose Carpets & Flooring reserves the right to exclude discounts on any product at their discretion.

**Bonus Rewards** - If the total of all purchases made under the affiliate member company name exceeds \$50,000 annually, the IDA member shall receive a bonus reward in the amount of \$500, payable within 60 days of the close of the calendar year in which member purchases exceeded \$50,000, net of taxes or ancillary charges.

**Cashiering** - The Affiliate Referral Fees shall not be due unless and until the products purchased have been delivered, accepted, and paid for in full. A.J. Rose Carpets and Flooring shall issue the Affiliate Referral Fees to the member on or around the 15th of the month following the month of delivery, subject to adjustments for canceled orders, product returns, or accommodations.

**Multi-owner/Multi-user Memberships** - A.J. Rose will provide one membership card per business. Business membership can be used by any employee with the official business membership card in their possession.

**Privacy** - A.J. Rose Carpets and Flooring Retail, Inc. respects your privacy. As a member of the Interior Design Affiliate Program, you agree to receive communications from us about exclusive designer events and promotions. You also authorize A.J. Rose Carpets & Flooring to use the information you furnish in your application for promotional exposure on the [ajrosecarpets.com](http://ajrosecarpets.com) website. **Tax Exemption** - IDA purchases do not qualify for tax exemption, unless proof of a tax exempt status is furnished to A.J. Rose Carpets and Flooring prior to or at the time of sale.

**Tax Liability** - A.J. Rose Carpets and Flooring will provide a year-end 1099 to IDA members who have received referral checks for purchases made through the Interior Design Affiliate Program. Reporting of referral payments received by enrolled designers is the sole responsibility of the designer and A.J. Rose Carpets and Flooring is in no way liable for member's failure to report rewards payments received.

**Termination of Membership** - Misuse of membership will result in membership termination. Misuse includes, without limitation: unauthorized use of A.J. Rose Carpets and Flooring logo or proprietary information; false or disparaging representations concerning A.J. Rose Carpets and Flooring products or services; transfer of membership; allowing unauthorized use of the membership card and submitting false, expired, or misleading information in connection with a membership application or client referral.

**Transfer of Membership** - Membership is a privilege and is not transferable. The membership card may only be used at a participating A.J. Rose Carpets and Flooring Design Center for purchases by clients of the member or by the member on behalf of their client—and only if the membership is current at time of purchase. The membership card may not be used for purchases made during certain special events—such as warehouse or clearance sales—or through any rewards programs or other similar types of events, at A.J. Rose Carpets and Flooring's sole discretion. Membership card is not valid for gift card purchases.
